

## Farm Ride Facility Hire

**Terms and Conditions** 

In booking this facility hire you accept these Terms &Conditions and acknowledge that the use of the Farm Ride has certain risks. You accept that Wellow Park Stables and anybody associated with the yard shall not be liable for any injury, loss or damage, which may occur. The yard does not insure yourselves, your horse or your tack or equipment. You are advised to make your own arrangements for insurance

Wellow Park Stables is NOT responsible for total or partial acts, occurrences, or elements of nature that can scare a horse, cause it to fall, or react in some other unsafe way.

All horses must be vaccinated for **Equine Influenza**, and must have had at least the first 2 initial vaccinations, be on annual boosters and must have had a least 7days clear from their last vaccination. Passport proof will be required.

**Riders Under 18yrs of age** must be accompanied at all times by a responsible adult either on foot or mounted

For safety reasons all lone riders must be accompanied by another rider or person on foot

Wellow Park Stables cannot be held responsible for the failure to comply with any of these terms and conditions.

You are to leave your transport in a suitable place within our car park area that does not block in any other vehicles or barn areas. Neither Wellow Park Stables or any of its staff shall in any way be responsible for any loss, injury or damages that may happen to the hirer or assistants or other members of the public, or to any animal or property or to any vehicle brought into Wellow Park Stables or while entering or leaving the same.

**ALL Droppings/Hay/Litter** from the arenas, seating area and car park must be removed. You may be charged if this is not undertaken.

**No Dogs**: persons or organisations hiring our facilities are requested **NOT** to bring dogs to Wellow Park Stables

Cancelations with less than 48hrs notice will not be refunded. Individual Farm Ride hires who cancel outside of this 48hrs will receive a full refund minus the booking fee.

You MUST:

- Have 3<sup>rd</sup> Party Liability Insurance
- Follow the map provided on our website
- Wear the correct PPE Riding Hat (of the current standards), Low heeled riding boots and preferably a body protector
- Wear Hi-Viz jackets and preferably something hi-viz on your horse
- Ride using a saddle and bridle
- Be respectful and courteous to other equestrian users and members of the public
- Dismount and lead you horse across the bridge
- Carry a mobile phone with you at all times
- Have provided your emergency contact details
- Ensure that you are at a sufficient riding level and ability to ride on the farm ride safely
- Ride at an appropriate speed and style of riding in accordance with the weather and ground conditions.
- Ensure that your horse is fit, healthy and suitable to ride on the Farm Ride
- Keep all gates closed
- Report any damages or hazards seen on the farm ride to the yard manager
- Only use the farm ride following the rules and advice of Wellow Park Stables both within this agreement and those which may be provided throughout the year

You MUST NOT:

- Deviate from the map
- Ride through or over any areas which are sign posted not to do so
- Use/jump any of the remaining Cross-country fences which are present on the ride
- Ride over or across any of the fields
- Ride on any footpaths
- No racing must take place at any time
- Use any of Wellow Park Stables yard equipment, horse pipes or tie rings
